

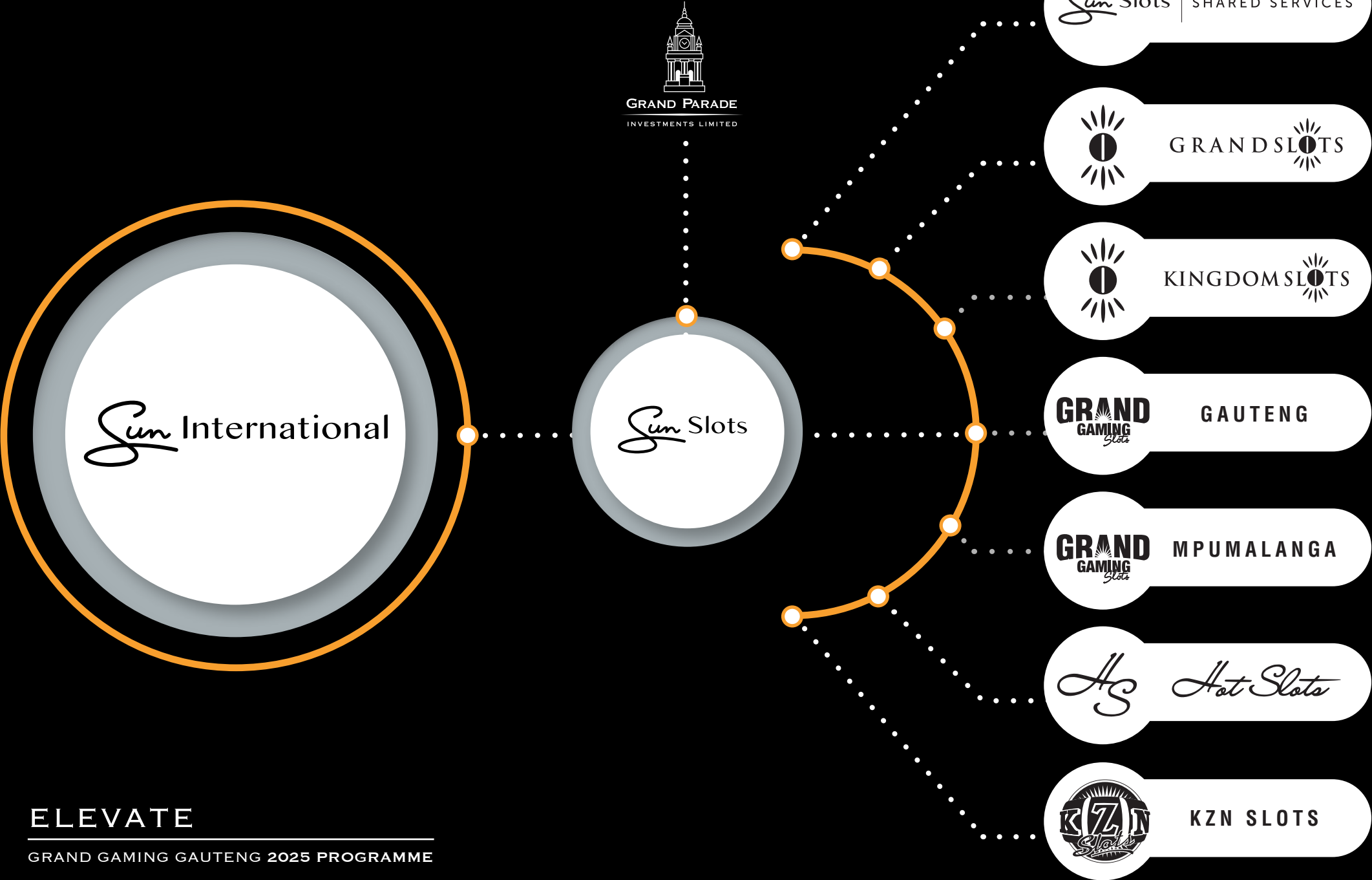

HOW DOES IT WORK?

WHO QUALIFIES?

- *Site owners with a valid Site Operator Agreement with Grand Gaming Gauteng are automatically eligible for the Elevate Incentive Programme.*
- *The LPM business must be operational on 01 January 2025.*

ASSESSMENT PERIODS

- *Assessment period 01 January to 31 December 2025.*

TIERS

- *The Tier / status will be based on the year to date classification as at the end of December, thus giving all sites a year to grow and move up a tier.*

HOW IS MY SITE'S TIER DETERMINED?

All sites will be assessed annually based on their average turnover (totals bets) per machine per day for the period January 2024 until December 2024. This will determine your tier for the 2025 programme.

Your Area Manager will confirm the tier you have been placed in for the year 2025 programme.

Annual Rebate Payment – Final Tier will be determined December 2025, payment made by Feb 2025

PENALTIES ON CASH EARNINGS

Any late payment or non-compliance will result in penalties on GGR rebate

**10%
LOSS**

If you commit any of the infringements (late payment, non compliance) 3-5 times, you will forfeit 10% of your potential pay-out/reward

**20%
LOSS**

If you commit any of the infringements (late payment, non compliance) 6-8 times, you will forfeit 20% of your potential pay-out/reward

**30%
LOSS**

If you commit any of the infringements (late payment, non compliance) 9 times and more, you will forfeit 30% of your potential pay-out/ reward

GAMING AREA PRIORITY LIST

Site investment will only be paid out to site owner if the minimum key items below are all in place.

RING FOR SERVICE' BELL IN THE GAMING AREA / DEDICATED GAMING ATTENDANT

VENTILATION AND AIRCON IN GAMING AREA IS ADEQUATE

FLOORING IN THE GAMING AREA IS IN A GOOD CONDITION

DOORS, DRYWALLS AND GLASS OF GAMING ROOM ARE INTACT AND IN GOOD CONDITION

TELEVISION IN THE GAMING AREA

TOILETS ARE ADEQUATE AND IN WORKING ORDER
